This critical role provides direct support to portfolio management, trading, client service, compliance, and technology functions. Reporting to the Operations Manager, the Senior Analyst will be responsible for trade support, trade settlement activities, portfolio accounting, client reporting, and operational technology oversight relating to these functions.

This is an exciting opportunity for someone with a strong investment operations foundation and a passion for improving systems and processes in a fast-paced environment. The ideal candidate brings both analytical rigor and systems expertise to investment operations. This position plays a vital role in ensuring the integrity and efficiency of our investment operations, which directly supports the firm's ability to serve institutional clients with excellence. You will have visibility across departments and a hand in strengthening our infrastructure for long-term growth.

### Trade Operations & Settlement

- Process and post trades/cash transactions in the portfolio accounting system
- Ensure timely and accurate trade settlement, coordinating closely with brokers and custodians
- Investigate and resolve trade discrepancies or fails
- Maintain and update client standing settlement instructions (SSIs) in ALERT
- Reconcile client accounts daily, resolving breaks in coordination with custodians and internal teams
- Set up and maintain security master data across systems
- Support portfolio managers and traders with operational trading workflows and troubleshooting

- Assist with processing of corporate actions

#### **Client Account Administration**

- Serve as a responsive liaison for custodians, clients, and broker-dealers regarding account-level questions or documentation
- Assist in preparing accurate, timely, and customized client reports

#### **Investment Guideline and Technology Support**

- Assist the Chief Compliance Officer with investment guideline monitoring and compliance system updates

- Troubleshoot day-to-day technical issues across investment systems; coordinate with vendors as needed
- Maintain and distribute end-of-day trade files and other operational deliverables

#### **Project and Process Improvement**

- Lead or support operational efficiency projects, including workflow automation and system enhancements
- Collaborate cross-functionally with investment, client service, and compliance teams to identify and implement scalable solutions
- Maintain internal operations documentation and manuals to ensure process continuity and compliance

#### **Required Skills / Responsibilities**

This position requires an individual who is detail-oriented, well organized, flexible, enjoys troubleshooting and is accurate with numbers. The successful candidate will be proficient with Microsoft Excel and other Microsoft products as well as with Bloomberg products particularly AIM and ideally PORT. Other requirements include good customer service skills and the ability to exercise initiative and prudent judgment. The person in this role must be reliable, able to work independently, and be proactive.

#### **Desired Skills**

- Bachelor's degree in business, economics, finance, accounting or closely related field.
- 7+ years of relevant experience in an operations
- Prior experience with Advent Axys / APX, Bloomberg, Omgeo OASYS, CTM and TradeSuite ID Web, a plus.
- Knowledge of fixed income securities is highly preferred and knowledge of mortgage backed securities is a plus.
